GIFT AID

If you are a UK taxpayer Stonyhurst could claim an additional 25p for every £1 you donate at no additional cost to yourself. In order for your gift to qualify for Gift Aid you will need to be a UK taxpayer and must pay an amount of income tax and/or capital gains tax at least equal to the tax to that which we will claim back on your donation.

HIGHER RATE TAX RELIEF

If you are a higher rate taxpayer, then you may claim further tax relief on your self-assessment tax return, you too can benefit from tax relief as you can claim back the difference between the higher rate of 40% and the basic rate of tax at 20% on the total value of the donation - a total of 20% of the gross amount of your gift.
